Scrutinizer's Report on voting through remote e-voting at the 101st Annual General Meeting Sub: of The Patna Electric Supply Co Ltd held on Saturday, September 28, 2024 at 1.30 p.m.

I, Md. Shahnawaz, Proprietor of M Shahnawaz & Associates, Company Secretaries, have been appointed as the Scrutinizer by the Board of Directors of The Patna Electric Supply Co Ltd (the Company) to scrutinize the remote e-voting at the 101st Annual General Meeting (AGM) of the Company held on Saturday, September 28, 2024 at 1.30 p.m. at 3 Khetra Das Lane, 1st Floor, Kolkata- 700012, pursuant to Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, Regulation 44 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 and Secretarial Standard on General Meetings.

#### **Despatch of Notice**

The Annual Report 2024, containing financial statements and other reports along with the AGM Notice dated August 24, 2024 (hereinafter referred as Notice of AGM), were sent to the members through electronic mode to those members whose e-mail Ids were registered with the Company or depository, as the case may be. The electronic transmission of the Annual Report was completed on September 3, 2024.

#### Cut-off date

The shareholders of the Company holding shares as on the "cut-off" date, i.e., September 21, 2024, were entitled to vote on the resolutions set out at item nos. 1 to 8 of the Notice of the AGM.

### Management's Responsibility

The Management of the Company is responsible to ensure compliance with the requirements of (i) the 2013 Act and the rules made thereunder; and (ii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Notice of the AGM.

#### Scrutinizer's Responsibility

My responsibility as a Scrutinizer is to ensure that the voting process, both through electronic means and by use of ballot at the meeting, are conducted in a fair and transparent manner and render consolidated scrutinized report of the total votes cast in favour or against, if any, on the resolutions to the Chairman, based on the reports generated from the electronic voting system provided by Central Depository Service (India) Limited (CDSL) and on the voting by use of ballots at the meeting.

I submit my report in respect of the resolutions passed at the AGM of the Company as under:
